1. AGREEMENT: GOODS, PRICE, TIME OF DELIVERY, PLACE OF DELIVERY, PAYMENT

- 1.1 The Seller agrees to sell and the Buyer agrees to buy the goods referred to in Schedule 1 at the price stated in Schedule 2 to be delivered to the place stated in Schedule 3 at the time and manner stated in schedule 5 and as set forth in this agreement and its other schedules.
- 1.2 Time for payment is of the essence. If the Buyer fails to make any payment on the due date then without prejudice to any of the seller's other rights the seller may:
 - 1.2.1 Suspend or cancel deliveries of any other goods due to the Buyer; and/or
 - 1.2.2 Appropriate any payment made by the Buyer to such of the goods (or goods supplied under any other agreement with the Buyer) as the seller may in the seller's sole discretion think fit.
- 1.3 All prices are plus GST and other taxes: GST & taxes are additional to the price and must be paid by the Buyer.
- 1.4 All sums due from the Buyer to the Seller that are not paid on the due date (without prejudice to the rights of the Principal under this Agreement) will bear interest from day to day at the annual rate of 4% over the current overdraft rate of the Seller's bank.
- 1.5 The Buyer indemnifies the Seller for full solicitor/client and other recovery costs relating to any default of the Buyer under this agreement.

2. SALE BY DESCRIPTION AND /OR SAMPLE

- 2.1 If it is a condition of this agreement that the goods shall correspond with the description then such description shall be set forth in Schedule 6.
- 2.2 If the sale is by sample as set forth in Schedule 6, as well as description, it is sufficient that the bulk of the goods correspond with the sample if the goods do not also correspond with the description.

3. NO UNDERTAKING AS TO QUALITY OR FITNESS AND EXCLUSION OF LIABILITY

- 3.1 All terms, conditions and warranties (whether implied or made expressly) whether by the Seller or its agents or employees or otherwise (other than those express warranties set out in the current edition of the Seller's specification) relating to the quality and/or fitness for purpose of the goods or any of the goods are excluded.
- 3.2 The Seller shall be under no liability whatsoever (whether direct, indirect or loss of profit) to the Buyer for any loss, damage, liability or injury suffered by the Buyer arising out of a breach by the Seller of this agreement.

4. PASSING OF RISK AND TRANSFER OF TITLE

- 4.1 The goods remain at the Seller's risk until the delivery to the Buyer, but when title passes to the Buyer the goods are at the Buyer's risk whether delivery has been made or not. Where delivery has been delayed through the fault of either Buyer or Seller the goods are at the risk of the party in fault as regards any loss which might not have occurred but for such fault.
- 4.2 If the goods are ascertained and in a deliverable state, or if the goods are not yet ascertained nor in a deliverable state when the goods are ascertained and deliverable, then the title in the goods then passes to the Buyer when the goods are delivered to the Buyer.

5. PPSR: SECURITY FOR PAYMENT

- 5.1 The Buyer (debtor) grants a security interest to the Seller, and the Seller may register the security interest, in all goods supplied by the Seller (secured party) to the Buyer (debtor) from time to time to secure payment of the purchase price.
- 5.2 Words herein have the same meaning as that which is given to them in Section 16 of the Personal Property Securities Act ("the PPSA"). If the Seller registers a Financing Statement in respect of any Security interest created by this agreement, the Seller does not have to provide a Verification Statement to the Buyer. The Buyer agrees that nothing in sections 114(1)(a), 117(1)(c), 133 and 134 of the PPSA shall apply to these terms and conditions. The Buyer agrees that its rights as debtor under sections 116, 119, 120(2), 121, 125, 126, 127, 129, 131 and 132 of the PPSA shall not apply to these terms and conditions.

- 5.3 The Buyer will immediately notify the Seller in writing of any change in the Buyer's name or other material identifying characteristics of either the Buyer or the Goods purchased.
- 5.4 The Buyer agrees that if at any relevant time, the secured party does not have priority over all other secured parties in relation to any collateral, then the Buyer and the Seller will, for the purposes of section 109(1) of the PPSA, be deemed, in accordance with the entitlement to do so under section 107(1) of the PPSA, to have contracted out of that section but specifically on the basis that, as between them and for the purposes of this security agreement and the operation and application of the PPSA, that section 109(1) (but amended only by the deletion of the words "with priority over all other secured parties") is reinstated and contracted back into.

6. PLACE AND MANNER OF DELIVERY OF GOODS


- 6.1 Subject to Schedules 3 & 4:
 - 6.1.1 It is for the Buyer to forthwith take possession of goods and not for the Seller to send them to the Buyer.
 - 6.1.2 The failure of the Buyer to pay for any one or more of the instalments of the goods on the due dates shall entitle the Seller (at the sole option of the Seller) without notice to suspend further deliveries of the goods pending payment by the Buyer; and/or to treat this agreement as repudiated by the Buyer. Delivery shall be at the place of business of the Seller. If the specific goods are in some other place than the place of business of the Seller then that place is the place of delivery. Where under this agreement the Seller is bound to send the goods to the Buyer the Seller is bound to send them within a reasonable time.
 - 6.1.4 When the goods at the date of this agreement are in possession of a third person there is no delivery by Seller to Buyer unless and until such third person acknowledges to the Buyer that the goods are being held on behalf of the Buyer subject to the issue or transfer by the Seller of documents of title to the goods.
 - 6.1.5 The taking possession or demand for or tender of delivery shall be treated as ineffectual unless during the normal business hours of the Seller and Buyer.
 - 6.1.6 The expenses of and incidental to putting the goods into a deliverable state for transit shall be borne by the Seller.

7. DELIVERY OF GOODS TO CARRIER

- 7.1 Subject to the express terms of this agreement, where the Seller agrees to send the goods to the Buyer at the expense of the Buyer then:
 - 7.1.1 Delivery of the goods to carrier, either named by the Buyer or falling such naming to a carrier at the discretion of the Seller for the purpose of transmission to the Buyer, is deemed to be a delivery of the goods to the Buyer.
 - 7.1.2 Unless the Buyer requires in writing otherwise the Seller shall make such contract with the carrier at limited carrier's risk within the meaning of the Carriage of Goods Act 1979.
 - 7.1.3 The Buyer shall be responsible to take steps to insure goods during carrying against loss due to any cause or deterioration.
- 7.2 If the Seller shall arrange for carriage of the goods to the Buyer's address, the costs of carriage and reasonable insurance shall be reimbursed by the Buyer without any set off or other withholding whatever and shall be due on the date for payment of the price. The carrier shall be deemed to be the Buyer's agent.
- 7.3 Where there is no agreement that the Seller shall send the goods to the Buyer, delivery to a carrier at limited carrier's risk at the expense of the Buyer is deemed to be delivery to the Buyer.

8. INSTALLMENTS

- 8.1 Subject to Schedule 4:
 - 8.1.1 The Buyer is not bound to accept delivery by installments.



8.1.2 Where it is agreed that the Seller shall deliver by stated installments which are to be separately paid for then if the Seller makes defective deliveries in respect of an installment or the Buyer refuses to take delivery of or pay for an installment, then the breach is at the choice of the Seller a severable breach, which gives rise to a claim for compensation, but not to right to treat the whole contract as repudiated.

9. DELIVERY: WRONG QUALITY, DEFECTS, DAMAGE, LOSS OR NON-DELIVERY

9.1 Subject to the express terms of this agreement, then:

9.1.1 Where the Seller delivers to the Buyer a quantity of goods 6% less than contracted, or 6% greater than contracted, the Buyer may reject all the goods. If the Buyer accepts the goods so delivered the full price must be paid for them adjusted pro rata at the rate of pricing in this agreement.

9.1.2 Where the Seller delivers to the Buyer the goods the Seller agreed to sell mixed with goods of a different description from that ordered the Buyer may accept the goods which are in accordance with this agreement and reject the rest or the Buyer may reject the whole.

9.2 The Buyer shall inspect the goods on delivery and shall within 14 days of delivery notify the Seller of any alleged defect, shortage in quantity, damage or failure to comply with description or sample. The Buyer shall afford the Seller an opportunity to inspect the goods within a reasonable time following notice and before any use is made of them. If the Buyer shall fail to comply with these provisions the goods shall be conclusively presumed to be in accordance with the agreement and free from any defect or damage which would be apparent on a reasonable examination of the goods and the Buyer shall be deemed to have accepted the goods.

9.3 The Buyer shall notify the Seller of any non-delivery of a full consignment of goods within 14 days of the date of dispatch (as stated on the invoice). Notwithstanding the receipt by the Seller of any such notice a clear signature on a carrier's delivery advice sheet shall be deemed to signify receipt of the quantity of goods indicated on the advice sheet.

9.4 The Seller shall not be liable for any loss or damage whatever due to failure by the Seller to deliver the goods (or any of them) promptly or at all. Notwithstanding that the Seller may have delayed or failed to deliver the goods (or any of them) promptly, the Buyer shall be bound to accept delivery and to pay for the goods in full provided that delivery shall be tendered at any time within one month of the delivery date.

10. UNPAID SELLER'S RIGHTS OF DISPOSAL

10.1 In the event that:

10.1.1 The Seller retains possession or control of the goods; and

10.1.2 Payment of the price of the goods, or any other goods, ordered from the Seller are due to the Seller; and

10.1.3 The Seller has made demand in writing of the Buyer for payment of the price in terms of this agreement; and

10.1.4 The Seller has not received the price of the goods

10.2 Then, whether the property in the goods has passed to the Buyer or has remained with the Seller, the Seller may dispose of any goods and may claim from the Buyer the loss to the Seller on such disposal.

10.3 The Seller reserves the foregoing right of disposal of the goods until the price is received by the Seller.

10.4 Where the goods are shipped and by the bill of lading the goods are deliverable to the order of the Seller or the Seller's agent the Seller reserves the right of disposal.

11. SALE NOT RESCINDED BY OBLIGATION OF BUYER TO PAY DESPITE LIEN OR STOPPAGE IN TRANSIT

11.1 Subject to this agreement the Buyer's obligation to pay the price is not discharged by the mere exercise of an unpaid Seller of the right of lien or retention or stoppage in transit or sale of the goods or part of them.

11.2 A transferee acquires a good title as against the Buyer where an unpaid Seller has exercised the right of lien or retention or stoppage in transit and resells the goods.

11.3 Where the goods are of a perishable nature, or where the unpaid Seller gives reasonable notice to the Buyer of the intention to resell, and the Buyer does not within a reasonable time pay or tender the price, the unpaid Seller may resell the goods and recover from the Buyer damages for any loss.

11.4 The sale by the Seller in terms of the lien or stoppage in transit or rights of resale for non-payment are always without prejudice to any claim the Seller may have for loss, and the Seller may claim from the Buyer for any other loss after payment of all expenses, directly or indirectly resulting from the breach of this agreement by the Buyer.

12. GENERAL

12.1 Subject to the Seller's order from which incorporates by reference the Terms and Conditions contained herein, where the terms of this agreement are at variance with the other documents relating to the order documents relating to the order of the goods specified herein, this agreement shall prevail. Any usages of trade, special agreement, or course of dealing between the parties at variance with the terms of this agreement are excluded.

12.2 If any term of this agreement is illegal, invalid or unenforceable for any reason whatsoever including, but without limitation, legislation or other provisions having the force of law or any decision of any court or other body or authority having jurisdiction, such term will be deemed to be deleted from this agreement on condition that if either party considers that any such deletion substantially affects or alters the commercial basis of this agreement it may give notice in writing to the other to terminate this agreement immediately.

12.3 Any notice, document, request, demand or other communication ("notices") to be given for the purposes of this agreement must be in writing. Time is of the essence.

12.4 The Seller may also delay delivery due to force majeure conditions including an act of God, fire, act of government or state, war, civil commotion, insurrection, embargo, prevention from or hindrance in obtaining any raw materials, energy or other supplies, labour disputes of whatever nature and any other reason beyond the control of the Seller.

12.5 The law of New Zealand including the Sale of Goods Act 1908 and its amendments shall apply to this agreement except to the extent expressly negative or varied by this agreement.

12.6 Interpretation:

12.6.1 "Seller" means the seller specified on the front-page together with the Seller's staff, agents and people acting on behalf of.

12.6.2 "Buyer" means the buyer specified on the front-page.

12.6.3 Headings are inserted for convenience and reference only and shall not affect the meaning or interpretation of this agreement.

13. PRIVACY

13.1 The Buyer authorizes and directs the Seller to seek and obtain from and supply any information concerning the credit or business standing of the Buyer to any other person whether trader, merchant, firm, organization, company, or any agency of source whatever including any credit agency or association or the like and directs any such person to supply or receive and record such information to and from the Seller.

14. CONSUMER GUARANTEES ACT 1993

14.1 If the Buyer is acquiring goods or services from the Seller for the purposes of a business, as defined in the Consumers Guarantees Act 1993, then the Seller excludes the guarantees contained in the Consumer Guarantees Act.

15. RESOLUTION OF DISPUTES

15.1 Consumer arbitration agreement:

15.1.1 This agreement contains an arbitration agreement.

15.1.2 You, if purchasing as a consumer as defined in the Arbitration Act 1996, certify that: having read and understood the arbitration agreement, and the variation of the default rules in the 2nd Schedule to the Arbitration Act 1996, you agree to be bound by the arbitration agreement.

15.2 If the parties are unable to resolve any question, dispute of difference arising under this agreement, by discussion and negotiation, the dispute must be submitted to the arbitration of a single arbitrator agreed on between the parties, or in default of agreement, to be nominated by the president of the New Zealand Law Society.
